- ❖ Permitted organizations must arrive at their stated arrival time for CHECK-IN and leave at their stated departure time. Please call the Division Superintendent the Monday proceeding your arrival date to make arrangements for cabin key pick up.
- ❖ Firewood will be provided by the District. NO WOOD may be brought in by the organization or collected from District grounds.
- ❖ Camping fees are not refundable. Permits are non-transferable or assignable.
- ❖ Your organization must not exclude any person from participation in, deny any person the benefits of or otherwise subject any person to discrimination because of the person's race, color or national origin during the use of Forest Preserve District facilities.

The undersigned accepts full responsibility for the conduct of the above group while on Forest Preserve property and agrees to indemnify and hold harmless the Forest Preserve District of Cook County from any and all liability which might be occasioned to said District by virtue of granting the permission requested in the application.
